

# Want To Perform Remote Online Notarizations?

As of January 1, 2020, a commissioned Florida Notary Public may register to perform remote online notarizations (RONs) using an audio-video technology provider that is compliant with Florida law.

## How Can I Become A Remote Online Notary?

If you would like to register as a remote online notary, simply complete the order form below. For your convenience, the required \$25,000 notary bond and remote online notary course has been pre-filled below. **Select a required Notary Errors & Omissions policy. The minimum amount required by law is \$25,000.** For pennies a day we offer coverage up to \$100,000. Once the order form is completed, scan and email, fax or mail it with payment to **Notary Public Underwriters, Inc.**

Your bond, E&O policy and access to the remote online notary course will be emailed to you within one business day along with instructions for completing the registration process at the State. If you are purchasing a replacement commission certificate, it will be mailed to you within one business day upon receipt from the State.
