
Application Process - Instructions will be emailed to you on how to complete the application process with the Clerk of Superior Court.

Email or Mail Commission Certificate - Upon receipt of your commission certificate, simply send us a copy of your commission certificate. We will ship your customized stamp and other supplies within 3 business days of us being notified of your commission. All Notary Public of America stamps and seals come with a Lifetime Guarantee.


