

# INSTRUCTIONS FOR NONRESIDENT RENEWAL AND SWEARING IN

## First Step - Application Process

**Important:** The enclosed application is for nonresidents, only. Missouri residents must use a different form. To receive the Missouri resident form, visit our website at: [www.NotaryPublicUnderwriters.com](http://www.NotaryPublicUnderwriters.com) or email: [info.mo@npuonline.com](mailto:info.mo@npuonline.com).

### STEP 1 ► ONLINE EDUCATION COURSE & EXAM

The state of Missouri requires notaries to complete a notary education course and read the Missouri Notary Public Handbook prior to submitting their notary application.

Visit [www.NotaryPublicUnderwriters.com](http://www.NotaryPublicUnderwriters.com) to complete the course and retrieve your exam. Once the course and exam are completed, print the exam and submit it with your completed notary application.

### STEP 2 ► APPLICATION

Print your name exactly as you want your commission to be issued. You should use your legal name, but you may use initials for your first and middle names.

Please enter your current commission expiration date.

Carefully read and answer questions 9-17 with "yes" or "no." Submit additional documentation if applicable.

Sign at the RED (X) exactly as your name is printed in #1.


*If you are not a citizen of the United States, but are a resident alien under Section 245 of the Immigration and Nationality Act, you may still become a Notary Public in the State of Missouri. You must send a copy of your "green card" along with your completed forms.*

### STEP 3 ► ORDER FORM

Select the products of your choice and add the appropriate Missouri state and local sales tax. Indicate your stamp case color where applicable.

### STEP 4 ► PAYMENT

Mail the application, exam and order form with a credit card number, check or money order made payable to **NOTARY PUBLIC UNDERWRITERS AGENCY** in the enclosed envelope.

## Second Step - Swearing In Process

- A) Within 10 business days of filing your application, you should receive a commission letter from the Secretary of State's office containing your county, commission number and your commission expiration date. If you do not receive the letter, please contact us at 1.800.821.0826 or [info.mo@npuonline.com](mailto:info.mo@npuonline.com).
- B) Email us a copy of your commission letter so we can send you your pre-paid bond.
- C) Keep the commission letter to complete the swearing in process at your county clerk's office. The clerk's office may also require a fee. **You will not be recognized as a notary public until we send your bond and you complete the swearing in process.**
- D) Once you have been sworn in, you will receive your commission certificate and instructions to mail your bond and oath to the state within 7 days.

**If you purchased your notary products from us, they will be mailed after you have sent us a copy of your commission certificate and we have verified your commission through the Secretary of State's website.**

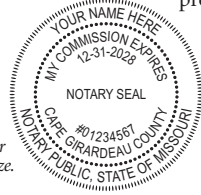

### Consider these Actual Cases:

- A property owner and a bank sued a Notary. She did nothing wrong, but was deceived by identity thieves. The Notary chose to pay to settle both lawsuits rather than endure prolonged litigation. *An Errors & Omissions policy would have protected her.*
