

Dear Notary:

Missouri Law requires any notary public who lawfully changes their name, address and/or employer county (non-resident notaries) obtain an amended commission. The enclosed forms provide everything you need to complete the amended commission process. Email or mail the following forms to us to complete the process:

Application for Amended Commission – Please make sure all blanks are filled in. Then sign at the red "X". Your signature must match your printed name in Line I. If any information is missing, your amended commission may be delayed.

Order Form – A new seal reflecting your name and/or county change is required by law. Select your new seal and any additional products you desire. Please make sure you add applicable state and local tax.

Once you receive your amended commission certificate from the Secretary of State's office, please email us a copy. We will verify your commission with the state and your notary supplies will be shipped within three business days.

Note: The amended commission process does not extend your commission; your expiration date will remain the same. Please contact our office at 1.800.821.0826 or info.mo@npuonline.com if you have any questions.
