Applying For a Notary Commission Just Got Easier...

Dear Notary Applicant:

Notary Public Underwriters Agency of Texas has made it easy for you to become a notary public. Follow the simple steps below!

STEP 1 ➤ Complete Notary Commission Form

Fill in all requested information on the enclosed Notary Public Commission Form. We will electronically transmit your information and bond details to the State of Texas, on the first eligible date.

Once submitted to the state, you will receive an email to create your account on the State of Texas' website to confirm your information, upload additional requested documents (if applicable) and sign your Statement of Officer. This must be done to complete the process! Failure to complete the final steps on the state's website within 90 days of the state accepting your application, will require you to reapply.

STEP 2 ➤ Order Form & Payment

Using the enclosed order form, select a Notary Package of your choice which includes the required bond. Return the order form, commission form and payment in the enclosed envelope.

STEP 3 ➤ Receiving Your Order

Once your commission is approved, your commission certificate will be available for download in your online Texas account. We will ship your notary supplies within 3 days of confirming your commission information.







Consider these Actual Cases:

- A property owner and a bank sued a Notary. She did nothing wrong, but was deceived by identity thieves. The Notary chose to pay to settle both lawsuits rather than endure prolonged litigation. An Errors & Omissions policy would have protected her.
